Surveillance Policy Of The Colonial Governments Upon the Political Suspects: A study On Chandernagore

Abstract:

During the swadeshi period the youths of Bengal formed different societies and groups in the various parts of the province. These types of society merely show their political activities publicly. The intelligence department were strongly noticed their activities. Amongst them these societies at Chandernagore were also took a crucial part against the colonial government. As Chandernagore was the French colony, so they have some advantages to take the French Law. Though the British Government was so much conscious about the political suspects of Chandernagore and took the connection with the French Administration about their activities. In this article we will try to locate the policy of the both Government towards the political suspects of Chandernagore through the different confidential and intelligence report.



Full Paper:

The youths of Bengal were formed different societies and groups in the various parts of the provinces during the Swadeshi movement. Like the other parts of Bengal, Chandernagore were also actively participated to the anti- British as well as anti-colonial movement .They formed various types of societies to united the people, like that, Club for physical activities , drama club, debating club, 'swadeshi bhandar' (to sale the indigenous products) etc. The youths of Chandernagore prepared themselves within this organization to the broader movement against the colonial rulers.

At the same time the British intelligence department was also aware of their activities. They named the workers of the Chandannagar as 'Chandernagore Group' or 'Chandernagore Party'. An intelligence report said that, "Our attention was first drawn in Chandernagore in 1907 in consequences of certain disturbances which took place there and information was at the same time received of the connection of Bengal revolutionaries with the Chandernagore Party." ²

Charuchandra Roy, the leader of the Chandernagore Party, was formed a society named 'Sathpathabalamby Sampradaya'3, the member of which took the path of honesty. Matilal Roy was the active soldier of that society. The British intelligence report depicted that Matilal Roy was the leader of the Boraichanditala section (southern part of the city) of the 'Sathpathabalamby Sampradaya'. During the investigation of the Dalhoussie Square Bomb Case the British Police has sketched diagrams of the Chandernagore revolutionary party. They knew about the detail from the two main accused of that Bomb Case, those were Narendranath Banerjee and Nanigopal Mukherjee. The structure of the Chandernagore revolutionary party was as sketched by the intelligence department as follow:



In this regard we can state here the details about 32 persons connected with the Chandernagore Revolutionary party. The information which were collected from the records of the Intelligence Branch has shown below: 5

In an official letter from C. J. Stevenson Moore, the Chief Secretary to the Governor of Bengal wrote to the Administrator, dee, Colonies. Chandernagore, ".......In conclusion I am to invite your attention to the need for the exercise of very special vigilance over all political suspects resident in Chandernagore just before and during the visit of their Majesties to Calcutta. The Lieutenant Governor-in Council feels sure that he can rely on your hearty cooperation to keep these persons under close observation on that important occasion."

Though the above mentioned two lists has made in different times, but a good number of suspects shown as common. During the conversation by official letters the British Government did not forget to remind the French officials to the incident

which occurred with Mousieur Tardival, the ex- Mayor of Chandernagore. They wrote, "...... it is known to the French authorities that the attempt that was made on for life of Mousieur Tardival in 1908 at Chandernagore by means of a bomb was the work of the revolutionary party:"

The British Intelligence Department emphasized that, "The attack made on Mousieur Tardival in 1908is sufficient evidence—if evidence were needed—that the activities of the revolutionists are not likely to be confused in attacks on British authority, but are directed against all foreign domination as such. The Lieutenant Governor-in Council therefore has to doubt that you will readily agree that measures of control are urgently called for------."

In reply to the letter of British government, M.H. GUIZONNIER, the Administrator of Chanderbnagore wrote to the Chief Secretary to the Govt. of Bengal on the subject of certain persons whom the British Government suspect to the connected with anarchical associations. He admitted, "......but I never adjusted that in my opinion either anarchists or revolutionaries existed in Chanderbnagore." In accordance to the incident regarding Mousieur Tardival, the Administrator mentioned in his letter, "It is unfortunately currect that in 1908 a bomb was thrown at the late M.Tardival, ex- Mayor, but it was never discovered whether this criminal attempt was a private act of vengeance on the work of the Bengalis appeared to be suffering from temporary excitement due to the 'swadeshi' movement in Calcutta."

Indeed this kind of statement, he assured to the British Government regarding the visit of their Majesties to Calcutta, "...... I am convinced that on this important occasion all Frenchman and French subjects in India will heartily join their enthusiastic acclaims ions to those of the inhabitants of British India, and that the entire population of Chandernagore will not far an instant forget the mutual sympathy which exists between our two great nations, nor the deep friendship which unites them." ¹³

The surveillance scheme did not apply not only within the Chandernagore, but in Calcutta also. In support of the statement we can quote a relevant portion of Government record, "The members of the Chandernagore Gang, seven or eight in number reside in Calcutta and being carefully noticed, but beyond the fact that some ------ attaches in the very frequent visits of Nagendra Ghosh and Satish Chakraborty to a house at 32 Harrisan Road ------."

So, the thorough supervision and surveillance over the revolutionary gang of Chandernagore was taken place by both the colonial rulers through different ways. To protect this kind of surveillance the members of the Chandernagore Gang has to take different defensive policy. As the 'Chandernagore Gang' was so organized and strong in its nature, they managed to abandoned the planning of the Government in different times and was able to continue their revolutionary activities throughout the Bengal and other parts of country.
